### ARTICLES OF INCORPORATION OF NEW MEXICO GEOLOGICAL SOCIETY FOUNDATION, INC.

(A New Mexico Nonprofit Corporation)

The undersigned, acting as the incorporator of a nonprofit corporation under the New Mexico Nonprofit Corporation Act, adopts the following Articles of Incorporation for such corporation (the "Corporation"):

### ARTICLE I

The name of the Corporation shall be: NEW MEXICO GEOLOGICAL SOCIETY FOUNDATION, INC.

#### ARTICLE II

The period of duration of the Corporation shall be perpetual.

### ARTICLE III

The Corporation shall be organized and operated exclusively for the benefit of, to perform the functions of, and to carry out the purposes of NEW MEXICO GEOLOGICAL SOCIETY, INC., a New Mexico nonprofit corporation, located in Socorro, New Mexico.

#### ARTICLE IV

The Corporation shall have no members.

### ARTICLE V

Upon dissolution or liquidation of the Corporation, and after paying or making provision for the payment of all the lawful debts and liabilities of the Corporation, the Corporation shall distribute all of the assets of the Corporation exclusively to NEW MEXICO GEOLOGICAL SOCIETY, INC., or its successor in interest, so long as NEW MEXICO GEOLOGICAL SOCIETY, INC. (or its successor in interest) is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code as an organization described in Section 501(c)(3) of such Code. In the event NEW MEXICO GEOLOGICAL SOCIETY, INC. (or its successor in interest) is not then exempt from federal income taxation under Section 501(a) of the Internal Revenue Code as an organization described in Section 501(a) of the Internal Revenue Code as an organization described in Section 501(a) of the Internal Revenue Code as an organization described in Section 501(c)(3) of such Code, then the Corporation shall distribute all of the assets of the Corporation to such one or more entities which are exempt from federal income taxation under Section 501(a) of the Internal Revenue Code as an organization described in Section 501(c)(3) of such Code as the Board of Directors shall determine.

#### ARTICLE VI

The address of the Corporation's initial registered office is 801 Leroy Place, Socorro, New Mexico 87801, and the name of the Corporation's initial registered agent at such address is Brian S Brister, Ph.D.

### ARTICLE VII

The number of Directors of the Corporation shall never be less than three (3). The initial Board of Directors shall consist of three (3) members. The names and addresses of the persons who are to serve as Directors until their successors are elected and qualified pursuant to the Bylaws are:

### ARTICLE VIII

The Board of Directors, except as limited by the New Mexico Non-Profit Corporation Act, and these Articles of Incorporation, shall require majority consent to make, adopt, alter, amend and repeal the Bylaws, fixing and altering the number of its Directors, and providing for the management of its property, and the regulation and government of its business and affairs.
